6. Chair Report - Earl

Downtown Dollars Tracking - Earl

Earl reported that, thanks to Annette's data collection, \$2,555.00 DDB Dollars were redeemed in February. A total of \$7,925.00 DDB\$ have been redeemed YTD and of this \$35.00 were redeemed from the 2021 DDB\$ promotion (total redemptions \$88,740.00 of \$93,365 sold), \$550.00 from the 2022 DDB\$ promotion (total redemptions \$89,740.00 of \$100,000 sold) and \$8,580.00 from the 2023 promotion (total redemptions \$8,580.00 of \$36,000 sold). Earl made 11 DDB Dollar merchant pickups in February.

Since 2018, when detailed records began, a total of \$59,745 unredeemed DDB Dollars remain in circulation.

Downtown Coach

Earl reported that he has confirmed a verbal agreement with the ECRM to purchase the DDB Coach at a price of \$20,000 payable in 2 annual instalments.

A quote from Provincial Glass & Mirror, to replace the 45 windows in the DDB Coach, was received at \$8,145.00 plus HST.

Historically, the DDB Coach was vinyl wrapped in April 2014.

Shop Hop

Annette is working to create a Passport for shoppers to use that day from 10am - 5pm for a chance to win 1 of 3 \$100 Downtown Dollar packages. 42 businesses have signed up so far. The passport will be uploaded to the website on April 22nd. Renee has sourced the Easter Eggs and Annette has ordered the Easter bunny costume. Home Show - April 12th - 14th

Annette provided an update on the search for volunteers to work the booth.

Annette also advised that 7 businesses including Jennings Furniture, Employment Services / Ignite Youth Centre, Opa's Pretzels, Lockwood Books, CTP Computers and MSM Fabrics have accepted the opportunity to display their business at the show with 3 spots remaining.

As a Whistle Stop booth, we will give away \$250 Downtown Dollars on each day of the show.

Setup will happen on Thursday April 11th at 5:30pm and tear down will happen on Sunday when the show ends at approximately 4pm - volunteers required. Earl reported that a new DDB booth display has been ordered to replace the old unit.

Nostalgia Nights Car Show

Earl provided a background report on the 10th Annual Nostalgia Nights Car Show scheduled for Saturday July 13th, 2024. The previous committee will be unable to plan and run the 2024 show. After a discussion a new committee consisting of Venessa - Chair, Jolie and Sarah Lynch was established.

8.2 Beautification Report - Vanessa

Downtown Business Street Signs

Vanessa reported that a sign for Studio 36 at 636 Talbot Street is scheduled for repair. Elgin Realty has asked for a new sign due to a logo change and a new sign for Zesty Market and Ignite / Steam Education is being worked on.

2024 Banner Program

A committee of Vanessa, Sarah V.P., Russell and Grayden was established at the February 7th meeting. The committee has been unable to meet but they have talked about a few ideas for a planned April 23rd installation date.

Summer Students

Earl reported that he has applied for Canada Jobs funding for 2 student positions and we are awaiting approval. The students that worked for us last year have expressed interest in returning this year.

8.3 Parks Dept Update - Adrienne

Adrienne supplied the following written report:

"All annual beds throughout the downtown will be planted as well as Greens Parkette (across from City hall) will be maintained.

We are currently in the process of reviewing and replacing some hanging basket hooks attached to the light standards from Ross to Alexandria, additional hooks will not be added at this time. This is to ensure the poles have the strength to hold the baskets when they are at their fullest late summer.

We are also reviewing the current locations of the planters and whether some will be moved back now that construction is completed on Talbot Street, however with the new design of the street the previous locations may be restricted."
